

## **TERMS AND CONDITIONS OF THE CONTEST VIDEO WMTDAY 2023**

### **1. GENERAL PROVISIONS**

- 1.1 These regulations ("Rules") define the rules of the "Video WMTDAY 2023" competition ("Competition"), in particular regulates the terms and conditions of participation in the Competition, the rules of awarding prizes and the rights and obligations of the Organizer and participants of the Competition.
- 1.2 The aim of the Competition is:
  - 1.2.1 Multimedia documentation of the educational campaign World Multiplication Table Day "WMTDAY 2023".
  - 1.2.2 Stimulating the creativity of Local Coordinators and the desire to promote their contribution to the organization of the World Multiplication Table Day "WMTDay 2023" through multimedia means.
  - 1.2.3 Popularizing the entertainment form of teaching the multiplication table.

### **2. ORGANISER**

- 2.1 The Competition is organized by company "Karty Grabowskiego Grabowski i Grabowska-Dybek Spółka jawna" based in Poznań, św. Szczepana 20A, 61-465 Poznań, Poland, NIP 7831849871, REGON 521011256, website [www.wmtday.org](http://www.wmtday.org); adres e-mail: [info@kartygrabowskiego.pl](mailto:info@kartygrabowskiego.pl), („Organizator”).

### **3. CONTESTANTS**

- 3.1 The competition is conducted on the territory of Poland and other member states of the European Union and selected other third countries.
- 3.2 The contest is exclusively addressed (i) to schools and educational institutions for school children and youth of school age acting under the applicable laws of the jurisdiction which (ii) have joined the organization of World Multiplication Table Day "WMTDAY 2023" in accordance with the license available on the [www.wmtday.org](http://www.wmtday.org) website ("Local Coordinators").

### **4. COMPETITION TASK**

- 4.1 The task of the Local Coordinators is to prepare one (1) short film lasting up to ninety (90) seconds and reporting on the course of the educational action World Multiplication Table Day "WMTDAY 2023", which meets the conditions specified in these Regulations ("Film").
- 4.2 The film may present in particular, but not only:

- 4.2.1 interesting forms of exams from the multiplication table;
  - 4.2.2 participants celebrating World Multiplication Table Day "WMTDAY 2023";
  - 4.2.3 interesting decorations or scenery related to the organization of the World Multiplication Table Day "WMTDAY 2023";
  - 4.2.4 other, arbitrary ideas of Local Coordinators related to the World Multiplication Table Day "WMTDAY 2023".
- 4.3 Every film sent withing the Competition must meet following requirements:
- 4.3.1 be no longer than ninety (90) seconds;
  - 4.3.2 be recorded at least at 720p resolution;
  - 4.3.3 be saved in one of the following audiovisual formats: MPEG4 (preferred), MOV, AVI, WMV;
  - 4.3.4 do not exceed 300 MB;
  - 4.3.5 contain the title and final inscriptions: (i) the name of the Local Coordinator and (ii) the names of the authors of the Film;
- 4.4 The film can't:
- 4.4.1 contain content that does not comply with applicable local law;
  - 4.4.2 contain content commonly regarded as offensive, vulgar, or discriminatory on any grounds;
  - 4.4.3 contain content inciting to hatred or violence;
  - 4.4.4 violate the good manners or rights of third parties, in particular the dignity, honor, good name, image and copyrights of third parties, including:
  - 4.4.5 contain a soundtrack to which the authors do not have copyrights or licences (it is recommended to use your own soundtracks).
- 4.5 Following people cannot take part in the Contest: (i) Organizer and people employed by the Organizer on the basis of an employment relationship or any other legal basis, in particular the contract of mandate or contract for a work or for the provision of services, as well as (ii) people employed on the basis of an employment relationship or any other legal basis, in particular the contract of mandate or contract for a work or for the provision of services, by entities cooperating with the Organizer in the preparation and implementation of the Contest.
- 4.6 Each Local Coordinator may submit only one (1) film to the Competition. If more than one (1) Film is submitted by one (1) Local Coordinator, the Organizer accepts only the Film, which was sent earlier.
- 4.7 The authors of the Films should be primarily the employees and staff of the Local Coordinators, but they may also be minors (students) provided that the Local Coordinator has received written consent to do so from the parent or legal guardian of such minor in accordance with Appendix 1 to the Regulations.
- 4.8 The Organizer may exclude films that do not meet the above conditions from the Competition.

## 5. RULES OF PARTICIPATION

- 5.1 The Organizer sets the following schedule for the Contest:
  - 5.1.1 **Until 17 November 2023** - The Local Coordinators are recording Films documenting the World Multiplication Table Day 2023 action organized in their location;
  - 5.1.2 **20 November 2023 - 15 December 2023** - The Local Organizers send their Film to the Organizer according to one of the ways indicated in point. 5.2 of the Regulations.
- 5.2 The Local Coordinators send the Organizer Films that meet the criteria indicated in point. 4 of the Regulations in one of the following ways:
  - 5.2.1 through the WeTransfer network application (<https://www.wetransfer.com>) enabling free file transfer without logging in, to: info@wmtday.org. In the form enabling sending (in the 'Message' field) please enter the license number of the Local Organizer.
  - 5.2.2 via Google Drive (<https://drive.google.com>), Dropbox (<https://www.dropbox.com/>) or YouTube (private video). Here you have to create your own account.
- 5.3 After sending the film, the Local Coordinator fills in the form for the participants of the Contest, which is located in the Organizers Zone of the World Multiplication Table Day "WMTDAY 2023" at the domain address: [www.wmtday.org/en/video-contest-2023-form](http://www.wmtday.org/en/video-contest-2023-form) ("Form").
- 5.4 In the Local Coordinator Form, the Local Coordinator provides a link to a shared movie file (in case it was placed on Google Drive, Dropbox or YouTube) or information that the file was uploaded using WeTransfer.
- 5.5 After receiving the Video from the Local Coordinator, the Organizer undertakes to confirm receipt of the Video by e-mail (to the e-mail address of the Local Coordinator, given in the share registration form).

## 6. SELECTING THE WINNERS AND PRIZES

- 6.1 The Organizer will appoint a Competition Committee to supervise the proper conduct of the Competition and review the films sent by the Local Film Coordinators ("Competition Jury").
- 6.2 The criteria for selecting the winning films by the Competition Jury will be as follows:
  - 6.2.1 The content of the film is consistent with the Competition's assumptions;
  - 6.2.2 The artistic and technical value of the film;
  - 6.2.3 original approach to the subject and creativity of the Local Organizers;
  - 6.2.4 the substantive and educational value of the film;

- 6.2.5 possibility to use the film during the media campaigns of the World Multiplication Table Day in the following years;
- 6.2.6 humorous aspects of the film.
- 6.3 The Competition Jury evaluates the films sent by the Local Film Coordinators and on the following days:
  - 6.3.1 **15 - 22 December 2023** - will select the ten (10) winning films from among them, following the criteria indicated in point. 6.2 of the Regulations;
  - 6.3.2 **2 - 12 January 2024** - will send the winners the prizes in the manner described in point. 6.4 of the Regulations.
- 6.4 The following prizes are provided for in the Competition depending on the number of participating Local Coordinators ("Awards"):
  - 6.4.1.1. For 1st place in the Competition - thirty (30) sets of Grabowski Math Cards "Multiplication" will be awarded to the Local Coordinator. (with descriptions of games), cup and diploma.
  - 6.4.1.2. For the second and third place in the Competition - fifteen (15) sets of Grabowski Math Cards "Multiplication" will be awarded to the Local Coordinator. (with descriptions of games), cup and diploma.
  - 6.4.1.3. For the 4th, 5th and 6th place in the Contest - five (5) sets of Grabowski Math Cards "Multiplication" will be awarded to the Local Coordinator. (with descriptions of the games) and a diploma.
  - 6.4.1.4. Diplomas will be awarded for places from VII to X in the Competition.
- 6.5 The Local Coordinators are responsible for providing free of charge the Awards to selected participants of the World Multiplication Table Day "WMTDAY 2023", based primarily on their involvement in their organization and participation in co-creating the Films, or leaving the Awards for the common use of relevant schools and educational institutions of the Local Coordinator. The Awards cannot be sold or otherwise given away for remuneration. The Local Coordinator is responsible for the payment of any local taxes and fees for the Awards (if applicable) in accordance with applicable local law.
- 6.6 All Local Coordinators whose films took part in the Competition and meet the criteria indicated in the Regulations will receive diplomas from the Organizer.
- 6.7 The winning films will be part of the official promotional film of the World Multiplication Table Day "WMTDAY" in subsequent editions of the action.
- 6.8 The names of all the Local Organizers who will send the competition videos will be placed on [www.wmtday.org](http://www.wmtday.org) in a special thank you section.

- 6.9 The Local Coordinators who received the Prize in the Competition are not entitled to exchange the Prize for its equivalent in cash.
- 6.10 The Organizer will send the winners of the Contest prizes by regular mail through a postal operator or courier.

## **7. MOVIES AND THEIR RIGHTS**

- 7.1 For Films meeting the conditions referred to above, the Local Coordinator grants to the Organizer or guarantees to grant to the Organizer a non-exclusive, free of charge, territorially unlimited license for a period of five (5) years or any other period in the scope most widely permitted by the applicable local law of the Local Coordinator (whichever is longer) to use them in the Organizer's own marketing and promotional activities in the scope of the World Multiplication Table Day "WMTDAY" on the fields of operation indicated below. After the expiry of this deadline, the license is transformed into a license granted for an indefinite period of time.
- 7.2 The license is granted for the following fields of operation:
- 7.2.1 recording or multiplying by any technique, including digital, in any system and on any medium;
  - 7.2.2 marketing, entering into computer memory and into the computer or multimedia network and telecommunication network and social networks (e.g. Facebook);
  - 7.2.3 making it available to the public in such a way that everyone can have access to it in a place and at a time chosen by them, in particular making it available on the Internet on social networking sites and on websites administered by the Organizer;
  - 7.2.4 public performance or public play;
  - 7.2.5 to exhibit, display, lend or hire copies;
  - 7.2.6 digital broadcasting and re-broadcasting (in any system or technology), inter alia, through digital platforms, cable networks, telecommunications connections, mobile services, IPTV, DSL, ADSL, any computer and telecommunications networks.
- 7.3 The Local Coordinator allows the Organizer or guarantees the right of the Organizer to make modifications and alterations to the Films and to develop them, in particular to improve the quality of their production, as well as to juxtapose them with the Films sent by other Local Coordinators and make them available to the public in this manner in the fields of operation indicated above.
- 7.4 At the moment of sending the Films, the Local Coordinator grants or guarantees to grant permission to the Organizer to disseminate his image and the images of people who have been recorded in the Films, to use them in the above-mentioned fields of exploitation for marketing and promotional purposes of the Organizer for the World Multiplication Table Days "WMTDAY", including without providing his personal data as the creator of the Film. In the case where images of minors are recorded in the Films, the Local Coordinator is obliged to ensure that the parent or legal guardian of the minor gives the appropriate permission in accordance with applicable local law (if applicable).

## **8. PERSONAL DATA AND PRIVACY**

- 8.1 Personal data of all participants in the Contest, in particular the Local Coordinators and their students, teachers and other staff, will be processed in accordance with the requirements of relevant European legislation on the protection of personal data and privacy, in particular Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC.
- 8.2 The administrator of personal data of the Contest participants is the Organizer, i.e. Mateusz Grabowski, an entrepreneur conducting business activity under the name of company "Karty Grabowskiego Grabowski i Grabowska-Dybek Spółka jawna" based in Poznań, św. Szczepana 20A, 61-465 Poznań, Poland, NIP 7831849871, REGON 521011256, . The data may be provided to a postal operator or courier to send the Prize. The transfer of personal data by the Local Organizers may be connected with making personal data available to operators or administrators of WeTransfer, Google Drive or DropBox services in accordance with the regulations and rules of using these services. The Organizer has no influence on the purposes and methods of processing personal data by the operators or administrators of these Internet services. The Organizer encourages you to familiarize yourself with their respective privacy policies. The data may also be made available to operators or administrators of social networking sites where the Organizer will post the winning Videos or their creations, such as Facebook. The Organizer encourages you to read the relevant Facebook privacy policies.
- 8.3 Personal data of the Contest Participants are processed for the purpose of organizing the Contest, in particular, contacting the Contest Participants, awarding or sending the Prizes provided for in the Contest, maintaining the Films on social networking sites and on the Internet, as well as for the purpose of dealing with any complaints and claims. The Entrant has the right to access and correct their data. Providing data is voluntary, but necessary for this purpose.
- 8.4 The above data of Entrants will be processed for the time for which they have licensed their Films or until the statute of limitations for Entrants' claims under the Competition - whichever of these terms ends later.
- 8.5 In all matters related to the protection of personal data and privacy, the Organizer asks for contact at the e-mail address [info@kartygrabowskiego.pl](mailto:info@kartygrabowskiego.pl). A person whose right to privacy has been violated by the Organizer may at any time submit a complaint to the Polish data protection authority, i.e. the President of the Office for Personal Data Protection (<https://uodo.gov.pl/>).
- 8.6 Other issues related to the protection of personal data and obligations of the Organizer are described in the Privacy Policy of the World Multiplication Table Day "WMTDAY 2023" available at [www.wmtday.org](http://www.wmtday.org). We encourage you to read this policy.

## **9. ADVERTISINGS**

- 9.1 Local Coordinators have the right to complain about the decisions of the Competition Chapter. All complaints concerning the Contest should be submitted in writing to the Organizer's address or via e-mail to [info@wmtday.org](mailto:info@wmtday.org)
- 9.2 The Participant has the right to lodge a complaint during and after the Contest, within thirty (30) days after the circumstances giving rise to the complaint occurred. The complaint should include the name and surname, e-mail address, correspondence address, the reason for lodging the complaint together with the justification and the content of the Contest Participant's request.
- 9.3 Complaints will be considered within fourteen (14) days of receipt by the Organizer. Complaints will be dealt with on the basis of the Regulations and applicable laws. The Organizer will send a response to the complaint in the form in which the complaint was submitted to the e-mail address or correspondence address provided respectively.

## **10. FINAL PROVISIONS**
